1. Key Details

- The lottery is being conducted by See Differently with the Royal Society for the Blind INC ABN 37680837839 See Differently with the Royal Society for the Blind.
- Ticket sales commence on Friday 21st March, 2025
- Ticket sales close at 9pm (ACST) on Friday 30 May 2025, unless sold out prior.
- One prize will be awarded (First Prize)
- A maximum of 2,500 tickets will be sold.
- Tickets are \$50 each.
- Total recommended retail value of all prizes is \$40,000.00

2. Prizes

2.1 First Prize

The First Prize winner will win a Toyota Corolla Cross Hybrid GX 2.0L Auto CVT 5 Door Hatch car which has been provided by Cornes Toyota and has an estimated recommended retail price of \$40,000.00. Tickets purchased before 9pm on Friday 30th May 2025 are eligible for First Prize.

2.2 Other details

- (a) The prize is not transferable, or otherwise substitutable, by the prize winner.
- (b) No component of the prize may be redeemed for cash.

(ii) the estimated collection date is approximately 7 days after the prize is claimed but may be subject to change.

3. Draws

3.1 Time and location of draw

3.2 Main Draw details

(a) The draw will be determined by lot using random number generator software developed for the purposes of assisting the conduct of lotteries.

(b) The draw will occur:

(i) under the supervision of; See Differently with the Royal Society for the Blind

(ii) in the presence of a scrutineer who is not associated with the See Differently with the Royal Society for the Blind or otherwise involved in the conduct of the lottery; and

(iii) in the presence of any ticket holders who wish to be present.

4. Winner notification and collection of prizes

4.1 Notification

(a) The winner will be announced during the See Differently Quiz night immediately following the draw.

(b) If the winner is not present, they will be contacted via a telephone call and email from See Differently with the Royal Society for the Blind within 7 days of the draw with information on how they may collect their prize.

(c) If a prize remains unclaimed for at least two weeks after it is drawn, See Differently with the Royal Society for the Blind will make additional attempts to contact that winner to ensure they are aware they have won a prize.

4.2 Publication

(a) The prize winner's name will be published:

4.3 Claim
